• Coverage from morning preparations up to the first dance and a bit of boogying.

Design and on-the-day styling of the wedding venue.

- This pertains to the banquet room of the venue with provision of décor and accessories for up to 15 tables; a bespoke feature design within the venue including props and decor;
- Venue walk-through and free consultation with the winning couple.
- Creative direction and collaboration with creative vendors ensuring a cohesive look throughout. (stationer, florist, cake designer etc.) ·
- Does not include any custom stationery requirements, linen or furniture hire.
- Further styling and features can be added but will be an additional cost.

- Includes delivery and set up of the cake at the venue, served on a signature Fern Cakery tray.
- Also includes consultation and a wedding cake taster box free of charge.
- Wedding cake taster boxes are available on set days throughout the year. This can be delivered (subject to location) or collected.

Last Colour Down

The choice of a wedding stationery suite from the Last Colour Down Studio Collection.

- Working with the winning couple, the design will be further customised to ensure that it aligns to their vision.
- Includes an invitation, with matching blank envelope, an RSVP with matching blank envelope and a Details card to the couple's specified quantity of guests.
- Covers the printing and 3 rounds of changes to the chosen semidesigned suite and delivery of wedding stationery to one address within Ireland. •
- Does not include 'on-the-day' stationery such as, but not limited to, table plans, menus, ceremony booklets, place-cards, signage, etc., or any extra/additional items such as but not limited to envelope/guest names printing, wax seals, vellum overlays, specialty printing (letterpress, foiling, embossing or debossing), envelope liners or bellybands.

- Any number above 80 to be paid for-
- Only food and drink purchased from us allowed on the premises except wedding cake ·
- Final number to be stated 1 week prior to event and surplus if any paid in full-
- Valued on the dates as stated with no financial alternatives for non use of any or all of the price

Michelle Treacy Millinery

Voucher to the value of 250e towards a Bespoke hat or headpiece for our Hero

- Can be used by any other member of the Bridal Party if desired.
- If the value of the piece chosen goes above 250e there will be an additional cost .
- In order to craft the perfect bespoke piece I will require at least 8
 weeks notice and at least 3 meetings in my Studio to ensure the
 perfect piece is created. Meetings can be tailored to meet client
 requirements, such as Video consult in the alternative

All suppliers have confirmed availability for the following dates: -October 14th, 2021, March 10th, 2022 March 27th, 2022 If none of these dates suit the couple, other possible dates will be discussed, but in this case all suppliers might not be available and their individual services will then be removed from the prize and the supplier indemnified from any claims and all financial responsibility arising for further cost incurred as a result.
- 4. The wedding will take place in the Republic of Ireland.
- 5.Individual contracts will be agreed between the winning couple and each individual supplier.
- 6.Business will not be taken away from any suppliers the couple have already booked. If you have already booked certain suppliers for your day, please inform us. The relevant supplier associated with this competition can then choose to offer you an alternative prize or will bow out of the competition without owing any alternative prize.
- 7.All professional images and videos taken by Aoife O'Sullivan Photography and Vowart Wedding Films, along with any images taken by any of the individual suppliers, may be used by all suppliers for advertising purposes across social media and individual websites/promotional material. By entering the competition, you consent to these images being used. The winners will be asked to sign an independent form consenting to the use of these images by the suppliers for the purposes of advertising their services
- 8.If additional services are required by the couple, these should be discussed with the relevant supplier directly, and any additional cost agreed. No duplicate suppliers should be used, in order to prevent conflicts of interest.
- 9. The closing date for the competition is midnight on 31st May 2020.
- 10.Once all entries are received, a winner will be selected based on their written entry and eligibility
- 11. The winning couple will be contacted via telephone and email, which is why we ask for this on your entry. The winning couple may also be announced on social media; however, privacy is paramount and therefore your full names / contact details will not be published

PRIVACY NOTICE

Article 2

To the extent that the performance by the competition providers of their obligations under this Agreement involves the processing of personal data (as defined in the Date Protection Act 2018 (DPA) and the General Data Protection Regulation (GDPR) (as amended, revised or replaced from time to time) on behalf of the winning couple, the competition providers agree:

- 26.9. In order for us to process your data on the basis of consent, please sign the signature block below and cross-out the relevant option (Yes/No) confirming I am permitted, based upon your consent, to process your data.
- 26.10. If you are unhappy with how we process personal data, we ask you to contact us so that we can rectify the situation.
- 26.11. You may lodge a complaint with a supervisory authority. The Irish supervisory authority is the Data Protection Commission.
- 26.12. If you do not provide us with your information for the purposes described above, we cannot provide you with wedding advice and/or services.
